2 To RATIFY the Process of Holding Remote Meetings

Milton Parish Council meetings are being held online according to [the Local Authorities and Police and Crime Panels \(Coronavirus\) \(Flexibility of Local Authority and Police and Crime Panel Meetings\) \(England and Wales\) Regulations 2020](#) which came into force on 4 April, and are following the guidance on holding remote meetings published by the National Association of Local Councils (NALC).

5 Clerk's/Chairman's report

From previous meetings:

- **A10 Trees** –Solicitor to check handover was completed by Highways England to Cambridgeshire County Council. Clerk to check for a Local Transport Plan. Awaiting feedback from the Solicitor.
- **Deeds missing** - Solicitor to send deeds to MPC
- **Adverse possession of land (Old School Lane and Willow Crescent)** – Solicitor to seek further advice and costing on adverse possession of land. Guidance for adverse possession has changed and is now less likely to succeed. Awaiting feedback from Solicitor.
- **LHI Application 2020/21** – Landbeach Road Bus Stop to extended tarmac standing area. **Funding not granted for this project. Clerk to source quotes for MPC to carry out this project.**
- **A14 Parish Legacy Fund** – Plans are on hold due to staff changes and the Coronavirus. The team has confirmed the project will still be delivered – date to be confirmed.
- **Double Yellow Lines – The Rowans and Fen Road/Coles Road** – Results from the survey have been compiled. 224 responses were received to the survey. 94% agreed and 6% disagreed with the proposal for The Rowans. 76% agreed, 21% disagreed, and 3% made no comment on the proposal for Fen Road/Coles Road. The next step of the application is to be applied for requesting Highways to evaluate the proposals. **It was agreed at the 4 November 2019 meeting item 11 to spend the £250 evaluation fee for each application for double yellow lines.**
- **The Sycamores Rec** – Clerk is seeking grant funding with The Big Lottery Fund and Cambridgeshire Community Foundation (Amey) next round opens June 2020.
- **CCTV Jane Coston Bridge** – AB: BT are due to install a telecommunication line – No date given as yet.

- **Fen Road bike track** – Emails have been received about the bike track that has been made in a field along Fen Road. The conversion of the field did not require planning permission. MPC have been advised to ask residents to keep a noise/events diary and send the information to South Cambs Environmental Department.

20/02336/SCRE – St John’s House, St John’s Innovation Park, Cowley Road, Cambridge – Request for EIA screening opinion for the proposed demolition of existing office building St John’s House, as associated structures and erection of 2 Class B office buildings and a transport hub, new landscaping, parking and associated infrastructure. **HAS NO RECOMMENDATION**

20/01761/FUL – 99-101 Cambridge Road, Milton, Cambridge – Demolition of existing single storey element, erection of rear single storey extension, two storey side extension with roof terrace, over cladding and reform roof profile of existing two storey building. **OBJECT: Overdevelopment of site, adding third storey with roof terrace, limited parking space and inconvenient arrangement, access to site for emergency vehicles with increased traffic, potential additional use over the designed capacity. To be referred to the District Council Planning Committee asking for a site visit**

20/01987/HFUL – 2 Hall End, Milton CB24 6AQ – Erection of a single storey home office/gym. **HAS NO RECOMMENDATION. Comment: Request a condition that this property should be used only subservient to the main dwelling and not for separate residential purposes.**

AB raised the issue of the pop-up cycle lane which has been painted along Cambridge Road referenced in her report. The following was discussed and agreed:

- 1) We welcomed the re-painting of the existing northbound cycle lane on the carriageway.
- 2) We welcomed the re-painting of the existing cycle lane northbound/southbound on the eastern pavement.

However we **object** to the newly installed southbound (dashed) cycle lane on the carriageway of Cambridge Road because:

- the southbound cycle lane is very narrow
- the remaining road width is barely enough for two cars to pass (only just over 4m in places)
- it is not clear to drivers whether northbound or southbound drivers have priority
- drivers in both directions are hugging the cycle lanes very closely, to avoid hitting oncoming traffic and risk hitting cyclists with wing mirrors
- drivers are experiencing 'near-misses' as cars approach each other head-on
- cars are veering off into the cycle lanes at the last minute to avoid collision.
- this scheme was installed without consultation or reference to the Safety Audit prepared for the original cycle scheme drawn up around 2000. The original cycle scheme, agreed by Bob Menzies, did not include a southbound cycle lane on the carriageway as he deemed there was insufficient width to be safe.

The Parish Council has this evening agreed on the following request:

The Parish Council respectfully request that

- the southbound (dashed) cycle lane on the carriageway be removed as soon as possible
- that road-lines be re-painted on **High Street**, Milton (which was the original proposal)
- a **20 mph zone** be installed in Milton from just south of the Tesco roundabout to north of North Lodge Park.
