Milton Parish Council Chairman's Annual Parish Report 2017/18



There are so many benefits to living in Milton. We are a bypassed village close to the A14, the Park and Ride and the Guided Busway, the Cambridge North Railway Station and the Science Park. We are within easy reach of the beautiful city centre and the famous colleges, universities and grounds. We also have Milton Country Park and the river to enjoy.

We have local shops, fast food outlets a doctors surgery and a post office as well as four pubs. Milton Primary School is well respected and so is our local secondary school, Impington Village College, to which there is a free school bus for most Milton residents. There is also a local village magazine which is delivered free to all residents as well as the village website and news system, all run by volunteers.

The Parish Council owns Tomkins Mead Nature Reserve and most of the open spaces and play areas in Milton. We have a well run Community Centre and 3 recreation grounds, tennis courts and a bowls green all managed for us by the Community Centre Charity. It is a very active village with many local groups and societies meeting in the village. I hope the following will give you some idea of the sorts of activities the parish council are busy managing to try to ensure Milton remains a pleasant place to live.

New Play Area in Coles Road to go ahead

I am absolutely delighted to announce that Milton Parish Council has gained grants and donations totalling £99,697 to cover the cost of replacing the play area by the Community Centre in Coles Road.

This is a fantastic achievement and is all down to the work of a small group of volunteers who joined the Parish Council Play Working Party in 2016.

Our Clerk, Sarah Corder, has also done a brilliant job of applying for grants and liaising with the grant funders to achieve the best outcome.

This project will provide a real boost to the people of Milton. It's fantastic that WREN (part of the Landfill Communities Fund) has awarded us £70,697 and we're really looking forward to our play park taking shape in July. We are also very grateful and acknowledge the grant of £23,200 we have received from the Amey Community Fund (part of the Landfill Communities Fund) which has contributed towards the cost of this project.

The Play Working Party first started to review what was already on all seven play areas in the village and plan a program of improvements and replacements as much of the equipment is now over 30 years old. They decided to replace the play area at Coles Road first as this is the most used play area in the village, being next to the Community Centre and the centre of many activities. They drew up ideas and contacted companies for quotes and with the plans from those companies they carried out a consultation on three plans. This summer we will see the installation of this new exciting play area. Well done to everyone.



Joint funded mobile speed indicator

We were offered the opportunity to jointly fund a speed activated sign with Landbeach and Waterbeach for use in all three villages. I am pleased to say this has now been purchased and a timetable has been agreed for when it will be available in Milton. This is a battery operated sign and can be installed in various locations. You will soon see it in operation – watch for it.

War memorial cleaned

The War memorial is now looking clean as the Parish Council agreed to have a specialised contractor give it a clean and submit a report on its condition.

Youth Club

We now have a contract with the Connections Bus Project to run a Youth Club at the Youth Building on the Sycamores Recreation Ground. It has taken a huge effort by all involved and in particular, Cllr. Hazel Smith, to find a contractor to take on this work when the County Council announced that they were discontinuing this service. Without this work the Youth Club would have had to close. Youth Club is Tuesday evenings during Term Time from 6.30pm – 8pm

A10 trees responsibility next to the Parish Council Allotments

Cllr Anna Bradnam, Clr Adam Horne and I have spent a considerable amount of time meeting with the County Council and arguing with them over the ownership and responsibility for the trees bounding our property alongside the A10. We are determined to prove that the trees are not our property and we are therefore not responsible for their maintenance. Recently a tree has fallen on our boundary fence and we contacted them to have it removed and to ask them also to repair our fence.

Milton Trolley Bus

We run a fortnightly minibus to Tesco for our elderly and infirm who need this service. This is a service that is valued by all those who need and use it and is supported by a grant from Milton Charities.

Community Care

We manage a community care scheme which is for village residents. The Parish Council receives grants from both the Milton Charities and South Cambs District Council towards the running costs of this scheme. The users of the scheme also pay a small charge. There are not many villages in the area that run this type of scheme and we are very proud of the work that is done to help our residents who need the support.

Planning

When a Milton planning application is received by South Cambs District Council they send a copy to us to consider and comment on. May I thank Cllr Rob Farrington who is Chairman of this committee as he often spends a considerable amount of time looking at planning applications and visiting the locations to help advise the committee when they are considering any comments they may wish to make.

Fen Road development

The developers have now put in a planning application to build 36 affordable homes on land off Fen Road beyond Goding Way. The Parish Council considered this application and has raised several concerns, the main one being the historic importance of the site.

Waterbeach Development

Although Milton is not directly affected by the proposed development of 11,500 new homes and the proposed relocation of Waterbeach Railway Station, Parish Councillors are attending the Forum Meetings where they receive updates on the plans and feed back any comments or concerns.

We will be affected by any changes to the A10 so we are keen to hear what is being proposed to deal with the extra traffic as well as ideas to improve public transport and cycling routes. Unfortunately the A10 study is not now due to report back until late 2019.

Website

We now have a revamped Parish Website www.miltonvillage.org.uk that has been designed by Cllr. Adam Horne. I would like to thank Adam for all his work designing the new look website and Paul Oldham (who has now left the village) for all his work over many years running our first website.

Maintenance

The main areas that this committee has been working on are: making sure our play areas are maintained and repaired, overseeing work on the allotments as well as grass cutting, and tree and bush maintenance on land

we own. Cllr. Adam Horne is often out in the village looking into maintenance issues that have been raised with the council.

Contractors

We employ several contractors, some on a yearly contract and some for specific projects and advice,

We have a grounds maintenance contract with Buchans who we are very pleased with. They maintain our open spaces, recreation grounds, allotments and verges. We also contract in some financial support from accountant, Griffith Kinsman who oversees pay and pensions for our staff and keeps us up to date on our spending trends and budgets. Our bus shelter windows are cleaned by another contracted service and we contract out our Youth Club service to Connection Bus Project. In addition we contract in legal advice including HR advice, cover for our Community Care Warden and Surveyor advice when needed. Our councillors oversee and review the work of these contractors on a regular basis.

Parish Staff and volunteers

The Parish Council has four part time members of staff: our clerk Sarah Corder working 20 hours a week, Office Support, John Barrett who has recently been appointed on an add-hoc basis, Village Cleaner Philip Adams who works 9 hours a week as well as a small band of volunteer village Litter Pickers who regularly meet and litter pick specific problem areas, and Community Care Warden Tracey Ebbon who works 25 hours a week. I am grateful to all our staff and volunteers who do a fantastic job.

We meet in the Bowls Pavilion and our main meetings are generally held on the first Monday of the month - see our website and notice boards for a full list.

Thank you to our Tree Warden Bob Waters who has been of great help over the years advising us where work needs to be carried out.

Also thank you to those who manage Milton Community Centre and Recreation Grounds. We are also very grateful to our County Councillor and District Councillor Anna Bradnam and District Councillor Hazel Smith for all the work they do.

Future

There was no election this year for Milton Parish Councillors as only 8 nominations were received by the District Council for the 15 positions.

I am confident these eight people will work hard to continue the good work on behalf of the village without which only a minimum service would be provided by the District Council. Please consider joining us so we can ensure the future of the council who with local volunteers and knowledge have served this village well over 124 years providing services at a local level.
