19 Milton Community Centre Report - September 2021

Maintenance: The 5 year fixed electrical test and PAT testing is under way and we have had the Fire Alarm, CCTV System. Intruder Alarms and Fire Extinguishers all serviced.

**Bookings:** We now have 45 regular groups and classes using our indoor facilities and continue to see an increase in requests for bookings. We now have more regular indoor users than before COVID and have seen the return of all but 2 of our previous users due to them stopping their classes.

In addition to regular groups we have had bookings with Cambs Hearing, Blind Veterans UK and Falls Prevention Service.

Kids-R-Us are still running Wraparound School Club sessions each weekday in the Annexe. Eddies Art Works continue to use The Youth Building at the Sycamores every week Monday to Friday. We have also seen the return of the Youth Club at the Youth Building on a Tuesday evening.

The 5-a-side pitch continues to be popular in the weekday evenings with a mixture of both adult and children usage and we now have 14 regular weekly bookings for it.

The recreational spaces have now passed over to football and netball. We now have 18 children's football teams and 2 adult teams using the facilities. The South Cambs Adult Friendly Netball League is also returning to Coles Road in October.

**Crime and Vandalism:** There has been no crime to report and we have seen a decrease in vandalism. We have had issues with anti-social behavior near the Annexe reported by Kids R Us and we regularly see litter from recreational drug use at Coles Road and The Sycamores.

20 County Councillor Report for Parish Council meetings in September 2021 - Cllr Anna Bradnam (Tabled) Amey Waste Treatment Facility, Waterbeach - an upgrade to comply with revised emissions limits.: In 2008, the County Council started a 28-year Waste Private Finance Initiative (PFI) Contract with its Contractor, Donarbon Waste Management, which was later acquired by Amey. The Waste PFI Contract includes services to treat food including garden waste using an In-Vessel Composting (IVC) facility and residual waste using a Mechanical Biological Treatment (MBT) facility, both located at the Waterbeach Waste Management Park. On 16 September the Environment and Green Investment Committee agreed the recommended options and the necessary expenditure to ensure the processing facilities are compliant with the IED and Environmental Permits to allow continued operation and treatment of waste collected at Household Recycling Centres and by city and district councils. In due course, this should reduce the odour nuisance we have experienced locally. You can read the committee paper here Document.ashx (cmis.uk.com)

Wastewater Treatment Plant Relocation: The County Council has been preparing its response to the consultation.

**Vaccine boosters:** The Government has announced that some people will be eligible for booster vaccinations. If you are over 50 or clinically extremely vulnerable, then you will be invited to get your booster vaccination by your GP or through the national booking service. If you are eligible because of your role as a health and social care worker then you will receive a letter shortly from your local authority setting out how to book for your vaccine.

NHS restructure & collaboration with County and District Councils

You may have read about the replacement of NHS 'Clinical Commissioning Groups' by the new 'Integrated Care System (ICS)' structure that comes into force next April. This is occupying considerable time and effort, as the County Council's statutory social care role means much joint working with the NHS

Recently GPs have joined up into **Primary Care Networks** (in Cambridgeshire and Peterborough there are 21 PCNs. Milton Surgery is part of the Cambridge Northern Villages PCN

Combined Authority News – transport and climate action

Mayor Nik Johnson is moving forward with bus franchising proposals. Currently 90% of bus services are commercial and councils therefore have no control over their routes, frequencies or fares. We urgently need at least a 24% shift to public transport from cars to reduce carbon emissions significantly and this won't happen unless we have attractive public transport alternatives. Bridget Smith has been appointed Lead Councillor for Climate Change, though consensus on action has been hard to reach. There will be a new Career Hub.

**Welcoming Afghan Refugees:** Thank you to local residents who have been in touch asking how they can support Afghan refugee families. The District and County Councils are working together to offer homes to three families escaping the terror in Afghanistan, using houses available through SCDC's private rental housing company. The County Council with specialist charities will make sure that these people have the access they need to support, education and health services so that they can start to rebuild.

Education Organisation Plan for Cambridgeshire has been updated for 2021-22

This document provides details of the Council's responsibilities towards childcare and education for the 0-19 age range, and up to the age of 25 for children and young people with Special Educational Need and Disability (SEND). It gives an overview of the projects which have been carried out in the last two years, as well as providing details of current pressures and our planned response to them.

The Early Years chapter also highlights where housing development is planned, and the additional childcare which may be required as a result.

All pupils and libraries to receive a new book on domestic abuse: Cambridge writer and illustrator Pam Smy's latest story, "The Hideaway", focuses on a child who runs away from home as he cannot bear the domestic abuse taking place between his mother and step-father.

County Council's New Shire Hall, Alconbury: Based at Alconbury Weald off the A1 toward Peterborough, there are no viable public transport connections from most parts of the county, a concern that that was raised at the time the location was first considered. It contains no space large enough for the Council to meet there.

**External review of This Land is underway**: A review of This Land, Cambridgeshire County Council's arm's length property development company, will be complete by November 2021.

Covid-19 cases in Cambridgeshire are still high, with the worst rates now North of us, and largely amongst midteenagers.

"Visit South Cambs": A new website – <a href="www.visitsouthcambs.co.uk">www.visitsouthcambs.co.uk</a> – launched this month and local residents are encouraged to use the new website to explore, discover and enjoy what South Cambridgeshire has to offer in terms of activities, places to eat, cultural attractions and green spaces. The new website also provides B&B, camping, hotel and self-catering listings, making it easier for visitors to find a place to stay to make the most of the district. Listing on the website is free for local businesses.

**End of shielding:** Government ministers recently decided to <u>end the option of advising Clinically Extremely Vulnerable individuals to shield</u>, and to close the Shielded Patient List (SPL) and end the Shielding Programme as a contingency support offer. This means people previously identified as CEV will not be advised to shield in the future,

and the Government will not be providing specific national guidance for them to follow.

Invitation to a Celebration of Diversity to mark National Hate Crime Awareness Week & Black History Month 2021: Colleagues at Cambridgeshire Constabulary are looking for volunteers to speak/perform at an evening event on 12 October at Peterborough Cathedral, to mark both National Hate Crime Awareness Week and Black History Month 2021. If this is of interest to you or you would like to put someone else forward, please contact Tiff Lane, Action Against Hate Co-ordinator at Cambridgeshire Constabulary.

**British East and Southeast Asian Heritage Month:** The Council is supporting and promoting British East and Southeast Asian Month, at a time when we welcome those with Hong Kong British Nationals Overseas passports to our village and towns.

**Civil Parking Enforcement – update:** The District Council is working alongside Cambridgeshire County Council and the Greater Cambridge Partnership to improve the way illegal parking is tackled in the area. The audit of the current condition of the lines and signs relating to parking will begin on 8 October and will take around six weeks.

Vaccinations for school children aged 12 to 15 years old: The Government has announced that healthy school-aged children aged 12 to 15 are eligible to have their vaccine. For healthy children of this age group in South Cambridgeshire, their vaccinations are being offered by schools' immunisation teams. These are the teams who usually do school-based immunisations. In our location this project is being run by Hertfordshire and East Anglia Community and School Age Immunisation Service. Within the next week, families should start receiving a letter detailing when their child's school's clinics will be held. Queries can be directed to the Hertfordshire and East Anglia Community and School Age Immunisation Service at <a href="https://doi.org/10.1001/journal.org

For 12-15 year olds who are from CEV/immunosuppressed households, if the child/young person attends a special school in Cambridgeshire and Peterborough, they will be contacted by their school offering a date for vaccination in the school setting. Otherwise, parents/carers of eligible children will shortly receive a letter from their GP Practice with details of where they can be vaccinated.

Alternative provision will be arranged for children who are home-schooled, in secure services or in specialist mental health settings.

### **SCDC Growth Fund Grants**

Growth Fund grant scheme - South Cambs District Council (scambs.gov.uk)
Businesses looking for help to scale up and grow can now apply for financial support from our new South Cambridgeshire Growth Fund, funded by the Government's Additional Restrictions Grant.

We are delighted that no less than eight businesses in Milton and Waterbeach Ward have been awarded grants from the Growth Fund up until mid-September.

The scheme is open to micro and SME applicants from any sector. They could be pandemic start-ups or established businesses looking to expand. A one-off grant of between £1,000 to a maximum of £50,000 will be awarded to successful applicants.



### Transport - Local Roads

Gas main installation works - Waterbeach and Milton (N to S)

**A10 near the BP garage**: currently laying electrical cables to the new site. Ducting has been laid in the verge and next week (beg Nov) they will be pulling in the cables in overnight.

This work is due to be completed by 12 November.

**Bannold Drove**: installation is progressing here this week, then will move onto private land.

**Kirby Road**: it turns out this was an area of old runway and the concrete and tarmac are very deep. It is taking a very long time to cut through it and they are having to install much deeper than elsewhere. This section of excavation is taking over three times longer than the other sections. They hope to finish this section by the end of October.

Cody Road: there are a few reinstatement faults that need to be tidied up.

**Green Side/Cattells Lane/Way Lane**: as connections are being made at each end, they need to be tested. Work is ongoing this week.

[County Highways will also be doing remedial works on the table-top crossing for one day this week over half-term. Fulcrum will not work that day to avoid two sets of traffic lights.

Cambridge Road: the centre line (on the bend) will be reinstated over an agreed section. This has been negotiated on our behalf by Street Works and is a generous gesture from the contractors as technically their installation barely touched the centre line, which was previously almost complete faded. However, on grounds of safety, it has been agreed that the contractor will re-instate the centre line in this area.

**Daffodils:** at the time of writing, some have been planted and some are still to do. Work is due to be completed this week (by end Oct).

**Ely Road Milton** – work is ongoing here and was due to complete this week but may need until 5 November.

**Cambridge Road, Milton:** Due for one final closure to connect to the parent main in Cambridge Road. This will require two-way traffic lights, first on one side, then on the other.

General: Final testing will run 8 – 22 Nov. No road closures will be needed.

Fulcrum aim to have the job finished by the end of November.



# Information from Highways England about forthcoming works on/around the A14:

Next weekend, the 30th & 31st October, we will start night-time permanent lining works to the northern half of the **J33** gyratory at **Milton** which will include a full closure of the A14 EB eastbound J33 exit slip (off the A14) with a diversion to **J34** (**Fen Ditton**) and back (nights only).

The following weekend, the 6th & 7th November we will complete the lining works to the southern half of the gyratory. We will maintain access to the A10 NB & SB and also to Milton village throughout. We will switch from inner ring management to outer ring management throughout the shift to accommodate the lining works.

Next Friday night, the 29th October, we will also be installing a partial inner ring closure to the Eastern bridge deck of the gyratory. This will remain on throughout the weekend (24Hr closure) and is to allow us to carry out gully remedial works on the gyratory. Below is where the partial closure and gully location is on the gyratory:

### Transport - Rail

Network Rail advise us:

Passenger numbers on the railway continue to increase, especially at weekends. We're continuing to focus on providing a reliable service to ensure a good passenger experience and to encourage others back to the network.

The next round of the **Ely Area Capacity Enhancement consultation** has been launched driven by the wish to increase the frequency of trains on the line to Ely: phase2b.elyareacapacity.com or <u>Home - Ely Area Capacity</u> Look for

Level crossing proposals - Ely Area Capacity — Bottisham Road (Bannold Road) — where they are proposing to change from the current half barriers to full barriers. These stay down for longer than half barriers.

- Burgess Drove level crossing Burgess Drove level crossing - Ely Area

Capacity – two options are being considered: Option 1 - closing the crossing to vehicles but retaining pedestrian access and Burgess Drove being made suitable for vehicle access or Option 2 – close the crossing with all access being via Bannold Rd crossing or paths.

Having visited residents and allotment-holders recently, I know what a blow either of these options would mean. Please have your say in the consultation. **Deadline is 28**November.

### **Education and Schools**

School ended for half term on 22 October and will reopen on the 1<sup>st</sup> November. In the context of rising cases, this break is helpful but there is a real risk around further mixing in the community and we expect a sharp rises in cases after the first week of school is complete. From the 15<sup>th</sup> October to 21<sup>st</sup> October, we identified 1,240 cases across 199 settings. This is a **significant increase** from the 808 cases reported the previous week.

- We are currently considering how we respond to the high case rates of Covid-19 across the county. We will be notifying schools in the coming week of any further recommendation for measures. Any measures will be dependent on the current rate of Covid-19 and an agreement from government on specific measures above those we can consider locally.

# Covid-19 vaccines are being offered to 12-15 year olds at large scale vaccination centres across Cambridgeshire and Peterborough

Mike Passfield, Clinical Operations Director for the Large Scale Vaccination Centres run by Cambridgeshire Community Services NHS Trust said: "In the coming days, it will become possible to book appointments for this age group at the majority of our large-scale vaccination centres via <a href="www.nhs.uk/covidvaccine">www.nhs.uk/covidvaccine</a> or by calling 119. Appointments for this age group will be available on Saturdays and Sundays from 8.30 am to 4.00 pm and from 4.30 pm to 7.30 pm on certain evenings at different sites. In addition, during half term week (25 to 31 October), appointments will also be available between 8.30 am and 4.00 pm."

"Vaccinations for 12-15 year olds cannot be accessed on a walk-in basis so please ensure you book an appointment before visiting our centres."

"Alternatively, parents and young people can still choose to access the vaccination programme being delivered in schools"

Dr Gary Howsam, Chair of the Cambridgeshire and Peterborough Clinical Commissioning Group, said: "The majority of 12 to 15 year olds are currently being offered one dose of the vaccine to give them the best protection against Covid-19. This includes children who turn 12 on the date of their vaccination....however, two doses eight weeks apart will be offered to children who are at high risk from Covid-19, or if they live with someone who is immunosuppressed." ### Health

Rates of Covid-19 in Cambridgeshire are now the highest they have been since recording began with hospital admissions also starting to rise. This sharp increase in recent weeks has largely been driven by transmission in the school children and this is causing serious disruption in schools as well as putting vulnerable children and parents at risk. For the week ending 15 October, there were 808 identified cases across 193 educational settings. This is a significant increase from the 649 cases reported the week before.

Rates are also starting to rise in the parental age ranges as well as in the over 60s and we are once again seeing outbreaks in care homes. The health service is also being impacted by increased Covid admissions as well as staff staying at home with children with Covid.

Jyoti Atri, Director of Public Health for Cambridgeshire, said: "With the Covid vaccine being our best defence, we continue to work directly with those communities where we know there to be greater hesitancy around the vaccine – including using community advocates and employers to share messages. We are also working with the CCG to promote booster jabs and flu jabs which will help protect our NHS, during the winter.

This includes rapid testing twice a week if symptom free, testing and self-isolation if displaying symptoms and following the hands, face, space message. People can book Covid vaccinations online at www.nhs.uk/conditions/coronavirus-covid-19 or by phoning 119. **Environment and Climate Change** 

Community Heat Initiative – and an e-bike ride to celebrate the project
An electric bike ride from Cambridge to Swaffham Prior, to highlight a landmark retrofit scheme took place on 21 October, to mark the global climate change conference COP26. The event was organised by Cambridgeshire County Council and the Cam and Pet Combined Authority. Riders picked up e-bikes from Newmarket Road P&R and cycled the nine miles to Swaffham Prior, nine miles away. The bike ride was held to highlight the efforts being undertaken in Cambridgeshire to make the county net carbon zero, with riders using either an electric or conventional bike.

The village is set to become the first in the UK to switch off oil and move onto zero-carbon heating, through ground source and air source heat pumps to heat homes. The county council – which declared a climate emergency in 2019 - has set a target to cut 50% of its own direct carbon emissions by 2023 and it is on track to achieve this. For the wider Cambridgeshire area, the intention is to aim for net zero by 2030. The project at Swaffham Prior includes an energy centre being created on adjacent farmland and a network of heating pipes under the village streets. The council is working with its technical partner Bouygues Energies & Services ("Bweegs"). Ground source heat pumps will be used to extract heat from the ground through a series of underground pipes. In warmer seasons, air source heat pumps will be used to absorb heat from the outside air which is then absorbed into a fluid. The fluid is passed through compressors (like a fridge in reverse) that increase the temperature, which in turn is used to heat the building and water circuits. I joined the group for the village tour.

Councillor Lorna Dupre, Cambridgeshire County Council's Environment and Green Investment Committee chair, said: "With so much focus on the environment for COP26 it was great to be able to showcase some of the innovative work being done in Cambridgeshire to tackle the climate emergency.

### District Councillors' Report to Parish Councils - November 2021

As we start writing our district councillor report, we note that it has been just a week since the brutal and senseless killing of Sir David Amess MP. This has made us once again reflect on the tone of political debate in our society. Although we would have held different views on many policies from him and many in the Conservative party, we nonetheless respect and admire his work as an MP, and the connection he made with his constituents in Southend West and before that in Basildon. Indeed, he was sadly killed whilst carrying out his important surgery work. We are all thinking of him and his friends and family at this time, and may they all find peace and justice.

### Waterbeach Community Forum (20/10/2021)

At the recent Waterbeach Forum online we had presentations from planners and developers, on the Local Plan and on the GCP Better Public Transport team as well as a heads-up about proposed changes to level crossings in Waterbeach. With so many items of local concern, there wasn't enough time to answer all the questions asked. Officers are collating the questions and seeking answers from the presenters — and in due course Qs&As will be available on the webpage here <a href="Waterbeach Community Forum - South Cambs District Council (scambs.gov.uk)">Waterbeach Community Forum - South Cambs District Council (scambs.gov.uk)</a> The next Forum will be in the New Year and we will adjusting agenda to ensure more questions can be answered. The whole point is for residents to be able to take part in the shaping of Waterbeach, both old and new.

### **Parish Council Sport Facility Survey**

Cambridge City Council and South Cambridge District Council are undertaking the development of a number of Sports Facilities Strategies, overseen by the Greater Cambridge Shared Planning Service and external consultants, Strategic Leisure Ltd. The purpose of these strategies is to provide a detailed overview of all indoor and outdoor sports facilities, including the quantity, quality, availability, and accessibility of these to help inform assessment of need and future planning for provision. ### Children and young people grant fund 2022

Last week SCDC launched a new Children and Young People's Grant, designed to support local voluntary organisations (including Parish Councils) that run groups and activities that support our young residents. Organisations can apply for funding grants of between £4,000 and £8,000 for projects which help to empower children and young people; helping them to build self-belief and make a positive difference to themselves and their community. The deadline to apply for the grants is Wednesday 10 November. Further information and an application form can be found on the <a href="SCDC website">SCDC website</a>.

### Coronavirus pandemic

As of 17<sup>th</sup> October the South Cambs case rate is 514 cases per 100,000 population, which is a higher rate than the district experienced even in the January peak. This sharp rise initially started a few weeks after the schools returned but has now spread up the generations to older age groups. In

Cambridgeshire, the Local Education Authority advice is now for all secondary age children (unless exempt) to wear masks whilst moving around indoor areas of the school site and to wear masks on buses whilst travelling to and from school. Primary schools have also been encouraged to make more use of masks. At Impington Village College the case rate has now started to see a slight decline. Hopefully the half-term break may alleviate the situation across all of our schools. The message is to exercise caution, socially distance, to consider using a face mask in crowded spaces, if you are not already doing so, and to book a booster vaccine once it is offered to you. A single dose of the vaccine is now being offered to children aged 12-15 which is being principally administered at school. If a child is clinically extremely vulnerable in this age group they will be offered two doses. ### **Modern Day Slavery**

18<sup>th</sup> October marked Anti-Slavery Day raising awareness of its existence in society and how and what we can do to combat it.

Slavery still affects people, even in South Cambridgeshire. In 2018, eight people were rescued from a local agricultural nursery after being found living in poor living conditions and being paid little, if any, money. As a Council, SCDC regularly works with vulnerable residents within the district, so the Council is often in a good position to look out for the signs of modern slavery and report any potential cases for further investigation. SCDC has recently published a Modern Slavery Statement for 2021-22 which sets out what it will do to combat modern slavery and human trafficking in the Council and its supply chain, as well as how we tackle exploitation within South Cambridgeshire.

### **New Consultations**

We are often awash with consultations however it is important to take part and make your views known. Here is a list of those that are probably of greatest importance locally.

The Greater Cambridge Local Plan: First Proposals opens on 1<sup>st</sup> November and runs until 13<sup>th</sup> December so for a period of six weeks. You may specifically want to comment on the proposed accelerated delivery of 1500 homes into this next plan (which runs until 2041) in Waterbeach New Town. This is NOT a proposed increase in dwellings just a proposed faster rate of build out. The proposed development of 'North-East Cambridge,' a site that straddles both the city and the district might also be of interest for comment.

Network Rail are currently holding a consultation running until 28<sup>th</sup> November concerning the need to increase the capacity by closing some level crossings and improving the barriers at others, to improve safety and allow more trains to run through Ely. This round is focusing on the network to the South of Ely and of specific local interest are significant proposed changes to level crossings at

Bottisham Road (Bannold Road) and Burgess Drove, Waterbeach. Visit <a href="https://phase2b.elyareacapacity.com/">https://phase2b.elyareacapacity.com/</a> to make your views known.
