When you contact us

The information you provide (personal information such as name, address, email address, phone number, organisation) will be processed and stored to enable us to contact you and respond to your correspondence, provide information and/or access our facilities and services. Your personal information will not be shared or provided to any other third party. No personal information will be shared with any third party other than those directly related to the specific issue being considered.

Information Security

Milton Parish Council has a duty to ensure the security of personal data. We will only keep your data for the purpose it was collected for and only for as long as is necessary. After which it will be deleted/shredded. (You may request the deletion of your data held by Milton Parish Council at any time)

Access to Information

Information Correction

Right To Object
